On this 10th day of June A. D. 1867, before me,⁽¹⁾ Clerk of the
County of Linn, Iowa, in and for the County and State above named, personally appeared
Mrs. Jane Smith aged 45 years, a resident of Appano Township, Missouri,
in the State of Missouri who being duly sworn according to law, doth on her oath make the following
declaration: That she is the widow of⁽²⁾ Angus Smith and the mother of
Thomas Smith who was a⁽³⁾ private in Company 2^d
commanded by Captain Miller in the⁽⁴⁾ 11th Regiment of⁽⁵⁾ Mo. Cav
Volunteers, and who⁽⁶⁾ died at New York on or about the 11th
day of October 1862, by reason of⁽⁷⁾ dysentery, a disease
contracted in the military service of
the United States, and in the line of his
duties.

She further declares, that her said son, upon whom she was wholly or in part dependant for support, having left no widow or minor child under sixteen years of age surviving, declarant makes this application for a pension, under the act of Congress approved July 14, 1862, and refers to the evidence filed herewith, and that in the proper department to establish her claim.

She also declares that she has not in any way been engaged in or aided or abetted the rebellion in the United States, that she is not in receipt of a pension under the second section of the act above mentioned, or under any other act, and that she has not married since the death of her son, the soldier above named.

She hereby constitutes and appoints Samuel H. Babcock her attorney, with power of substitution to prosecute her claim and procure a certificate with full power and authority to do and perform all and every lawful act and thing whatsoever necessary and requisite to be done in and about the premises, except drawing the money, which will be hereafter provided for, she hereby making all former powers of attorney by her deceased husband ⁽¹⁰⁾ Samuel H. Babcock sworn to and subscribed before me, the day and year first above written; and also, personally appeared James W. Jones a resident of Hancock Co. Missouri and Wm. A. Jones a resident of Hancock County, Missouri persons whom I certify to be respectable and entitled to credit, who being duly sworn according to law, declare that they are personally acquainted with Mrs. Jane Smith who has made and subscribed the foregoing declaration in their presence, and were personally acquainted with her and her son before he entered the military service of the United States. That her son, the said Thomas Smith was the person who served as stated in said declaration. That from their knowledge of and acquaintances with the family of the declarant and her son, the soldier above named, they know that he left surviving no widow, or child, or children under sixteen years of age; that she was wholly or in part dependant upon him for support, and that she was the wife and is now the widow of⁽²⁾ Angus Smith and has been a widow since the death of her said son. That they reside as above stated and have no interest in the prosecution of this claim.
